**FR****Instructions d'utilisation****IMPORTANT— LIRE ATTENTIVEMENT — A CONSERVER POUR RÉFÉRENCE ULTÉRIEURE**

- a) **AVERTISSEMENT** Les lits surélevés et le lit supérieur des lits superposés ne conviennent pas pour les enfants de moins de six ans en raison du risque de blessures liées à des chutes.
- b) **AVERTISSEMENT** S'ils ne sont pas utilisés correctement, les lits superposés et les lits surélevés peuvent présenter un sérieux risque de blessure par étranglement. Ne jamais attacher ou suspendre des éléments à des parties du lit superposé qui ne sont pas destinés à être utilisés avec ledit lit. - a) **WARNING** Raised beds and the upper bed in a bunk bed assembly are not good for children under 6 years old because of the risk of injury from falling from such beds.
- b) **WARNING** If the raised and bunk beds are not used correctly, they can present a serious risk of injury from strangulation. Never attach or suspend things from the upper bunk bed that are not going to be used with that bed. Such things include - but are not limited to - cords, string, sashes, hooks, belts and bags.
- c) **WARNING** Children can find themselves trapped between the bed and wall, or inclined roof wall, ceiling, adjacent pieces of furniture (such as cupboards) or other items. To avoid any risk of serious injury, the distance between the upper safety barrier and surrounding items should not exceed 75 mm (2 15/16") - or the distance should be greater than 230 mm (9 1/16").
- d) **WARNING** Do not use the upper bunk bed or a raised bed if a part of the structure is missing or broken. Spare parts should be requested from the manufacturer or shop.
- e) It is essential that the manufacturer's instructions on assembly and use are followed.
- f) The recommended size of the mattress to be used with the bed is 90cm x 200cm (35 1/2" x 79").  
**Maximum mattress thickness: 15cm (5 7/8").**  
The upper surface area of the mattress must not exceed the limit indicated on the side of the bed.
- g) Mattresses must be aired to maintain a low humidity and to stop moisture building up in the bed and its surroundings. Maintenance: Clean with a wet sponge and warm soapy water. Never use abrasive products.

## **Instrucciones de empleo**

### **IMPORTANTE — LEER CON ATENCIÓN — CONSERVAR PARA FUTURAS REFERENCIAS**

- a) **ADVERTENCIA** Las camas elevadas y la cama superior de las literas no son convenientes para niños menores de seis años debido al riesgo de lesiones por caída.
- b) **ADVERTENCIA** Si no se emplean correctamente, las camas elevadas y las literas podrían presentar riesgo de lesiones por estrangulación. No enganche o suspenda elementos a las partes de la litera que no estén destinadas a emplearse con la cama. Estos elementos pueden ser, sin que por ello la lista sea limitativa, cuerdas, cintas, cordones, ganchos, cinturones y bolsas,
- c) **ADVERTENCIA** Los niños podrían quedar atrapados entre la cama y la pared, una parte del techo inclinada, el techo, muebles adyacentes (armarios por ejemplo) u otros. Para evitar cualquier riesgo de lesión grave, la distancia entre la barrera de seguridad superior y los elementos que la rodean no deberán superar los 75 mm o ser superiores a 230 mm.

## **NL** Gebruiksaanwijzingen

### BELANGRIJK - AANDACHTIG LEZEN - TE BEWAREN VOOR LATERE RAADPLEGING

- a) **WAARSCHUWING** De verhoogde bedden en het hoge bed van stapelbedden zijn niet geschikt voor kinderen jongeren dan zes omwille van het gevaar op kwetsuren door valpartijen.
- b) **WAARSCHUWING** Wanneer ze niet correct gebruikt worden, kunnen verhoogde bedden en stapelbedden een ernstig gevaar inhouden op kwetsuren door wurging. Nooit dingen bevestigen of ophangen aan delen van het stapelbed die niet bestemd zijn voor gebruik met het desbetreffende bed. Deze elementen omvatten, zonder hiertoe beperkt te zijn, koorden, touwen, snoeren, haken, riemen en zakken of tassen.
- c) **WAARSCHUWING** Kinderen kunnen vast komen te zitten tussen het bed en een muur, een deel van het hellend dak, het plafond, naburige meubels (bijvoorbeeld kasten) of andere zaken. Om elk gevaar op een ernstige kwetsuur te vermijden, mag de afstand tussen de bovenste veiligheidsstang en de omliggende elementen niet groter zijn dan 75 mm of moet deze groter zijn dan 230 mm.

## Instrukcja obsługi

### WAŻNE - PRZECZYTAJ UWAŻNIE - ZACHOWAJ DO PÓŹNIEJSZEGO WGLĄDU

- a) **OSTRZEŻENIE** Łóżka piętrowe pojedyncze oraz łóżko górne w łózkach piętrowych nie nadają się dla dzieci poniżej szóstego roku życia wze względu na niebezpieczeństwo obrażeń ciała związanych z upadkiem.
- b) **OSTRZEŻENIE** W przypadku nieprawidłowego używania łóżek piętrowych podwójnych i pojedynczych, mogą one stwarzać poważne niebezpieczeństwo obrażeń ciała związanych z uwięzieniem. Nigdy nie należy przyczepiać, ani zawieszac elementów do części górnego łóżka, które nie są przystosowane do właśnie takiego użycia. Elementy te to, nie ograniczając się do wymienionych, linki, wstążki, sznurki, haczyki, paski i torby.
- c) **OSTRZEŻENIE** Dzieci mogą zaklinować się między łóżkiem i ścianą , pochyloną częścią dachu, sufitem, przyległymi meblami (na przykład szafą ) lub innym elementem konstrukcji. Aby uniknąć poważnych obrażeń ciała, odległość między górną barierką zabezpieczającą , a elementem sąsiadującym, nie może przekraczać 75 mm, lub musi być większa niż 230 mm.
- d) **OSTRZEŻENIE** Nie używać górnego łóżka lub pojedynczego łóżka piętrowego, jeżeli brakuje jednego z elementów konstrukcyjnych lub jest on zniszczony. Części zamienne należy zamawiać u producenta lub w sklepie.
- e) Należy przestrzegać instrukcji montażu i obsługi, dołączonej przez producenta.
- f) Zalecany rozmiar materaca pasującego do tego łóżka to 90cm x 200cm.  
**Maksymalna grubo materaca: 15cm.**  
Górna powierzchnia materaca nie powinna przekraczać ograniczenia wskazanego na ścianie łóżka.
- g) Należy wietrzyć pomieszczenie, aby utrzymać wilgotność powietrza na średnim poziomie i uniknąć rozwoju pleśni w łóżku i w jego okolicy. Konserwacja: Czyszczenie za pomocą wilgotnej gąbki, ciepłej wody z mydłem. Nigdy nie używać produktów o silnym działaniu ściernym.
- h) Elementy montażowe muszą być odpowiednio dokręcone i systematycznie sprawdzane. Dokręcić w razie potrzeby.
- i) Biorąc pod uwagę ryzyko wystąpienia pożaru, nie należy umieszczać łóżka w pobliżu grzejników elektrycznych, gazowych oraz wszelkich innych źródeł ciepła mogących wywołać pożar.
- j) Zgodnie z europejskimi wymogami bezpieczeństwa normy NF EN 747+A1: 2015.

**CR** UPUTE ZA UPOTREBU

VAŽNO – PAŽLJIVO PROČITATI – SAČUVATI ZA NAKNADNO ČITANJE

- a) **UPOZORENJE** - Gornji krevet ovog kreveta na kat nije prikladan za djecu mlađu od 6 mjeseci zbog opasnosti od ozljeda uzrokovanih padom.
  - b) **UPOZORENJE** - Ako se ne koriste pravilno, ovi kreveti na kat mogu predstavljati velik rizik od gušenja. Ne vješajte predmete na dijelove kreveta na kat koji nisu namijenjeni za upotrebu s tim krevetom. To uključuje, bez ograničenja, konope, vrpce, užad, kukice, pojaseve i torbe.
  - c) **UPOZORENJE** - Djeca se mogu zaglaviti između kreveta i zida, kosog krova, stropa, susjednog namještaja (ormara, recimo). Da biste izbjegli rizik od ozljeda, udaljenost između gornje sigurnosne ograde i drugih predmeta mora biti manja od 75 mm ili veća od 230 mm.
  - d) **UPOZORENJE** - Ne koristite gornji krevet ako neki dio nedostaje ili je slomljen.
  - f) Preporučene dimenzije madraca: 90cm x 200cm. **Madrac gornjeg kreveta može biti maksimalne debljine 15cm.** Oznaka debljine koja se ne smije premašiti navedena je na jednoj od dužih stranica gornjeg kreveta.
  - g) Redovito provjetravajte prostoriju kako bi se održavala relativno niska razina vlage i spriječilo pojavljivanje plijesni na krevetu i oko njega.
  - h) Vijci i sastavljeni dijelovi trebaju uvijek biti ispravno stegnuti kako bi se ograničio rizik od toga da se uzica, traka, ogrlica ili sličan predmet zakvači te izazove gušenje ili davljenje. Treba redovito provjeravati jesu li elementi dobro stegnuti.
  - i) Upozorenje: Pazite na opasnost od stavljanja kreveta u blizinu otvorenog plamena i drugih izvora jake topline, poput električnih uređaja za grijanje, plinskih uređaja za grijanje i slično.
